

MLB VIP EXPERIENCE - OFFICIAL RULES

- 1. SWEEPSTAKES DATES:** The MLB VIP Package Experience Sweepstakes (the “Sweepstakes”) begins on or about **3/1/2023** and ends at 11:59pm ET on **05/31/2023**.

The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible by assigning email addresses or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Use of any device to automate entry is prohibited.
